Terms & Conditions:

›Qualified appliances must be purchased between January 1, 2012 and December 31, 2012.
›All rebate forms must be postmarked no later than January 16, 2013.
›Each utility customer of record is only entitled to one (1) rebate per appliance type per year. No one utility account shall exceed four (4) rebates of \$175 during 2012.
›Customer must receive electric service from HG&E to be eligible for rebates.
›Funding for this program is limited and HG&E reserves the right to stop issuing rebates at any time due to program funding depletion.
›Used or refurbished appliances do not qualify for a rebate. Appliances included in the purchase of a residence are not eligible to receive a rebate.
›Appliance eligibility is based solely upon the appliance list at: www.energystar.gov
