The Residential Energy Conservation program can provide homeowners and owners of multi-family properties with the money they need to make energy-saving improvements to their buildings.

- ▶ **the program provides 0% interest assistance, repayable over up to 5 years with the following limits:***

Single family (owner occupied)	\$5,000
Multi-family (owner occupied)	\$10,000 (up to \$5,000/unit)

- ▶ **repayment charges appear on your monthly HG&E bill**

* owners of multi-family investment properties (non owner occupied) must apply for funding under the HG&E Commercial Assistance Program

Audit your building for energy savings.

HG&E offers zero-interest assistance to install energy conservation measures in owner-occupied residences.

- ▶ **additional insulation**
- ▶ **replacement windows**
- ▶ **high efficiency gas fired boilers and water heaters**

Is your home or building too cold in the winter and too warm in the summer? If so, then this might be a sign that you need additional insulation.

Insulation slows that rate at which warm or cool air escapes from your building. Insulation can also stop the flow of outside air into your living space.

Effective insulation can save you 13% on your monthly utility bills, usually costs just a few hundred dollars, and can even be completed without a contractor.

The HG&E Residential Energy Conservation Program covers:

- ▶ Attic Insulation (final value of R-34 or lower)
- ▶ Wall Insulation (final value of R-11 or lower)
- ▶ Basement Insulation
- ▶ Rim Joist Insulation

13% energy savings is based upon a home where 44% of utility costs are related to heating or cooling and an average 30% reduction in those costs through weatherization measures.

Energy Star rated windows can save up to \$340/year when replacing single pane glass windows

Energy Star qualified replacement windows, doors and skylights save you energy and money, increases home comfort and protects your valuable home furnishings from the sun's damaging rays.

The advanced technologies in Energy Star windows, like glass coatings and gas fills, deliver substantial improvements over standard double-paned windows.

The HG&E Residential Energy Conservation Program covers:

- ▶ Replacement windows and doors (Energy Star rated with a U-factor of .35 or less)
- ▶ Replacement skylights (Energy Star rated with a U-factor of .6 or less)
- ▶ Storm windows

Replacement window savings estimate based upon a 2,000 sq ft, single story detached house with 15% glazing, gas heat and electric air conditioning. Actual savings will vary based upon your home. Visit www.energystar.gov/windows for details.

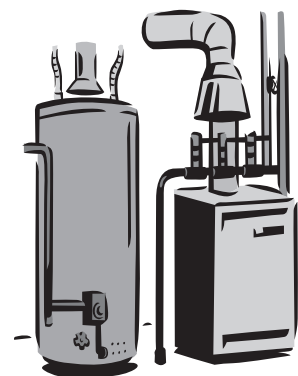

Did you know that a 20-year old boiler may have an efficiency rating of 60% or less? That means that 40% of your energy dollar isn't used to heat your home.

Upgrade to a modern 85% efficient furnace or boiler and you'll **save about 30% on your home's heating costs.**

The HG&E Residential Energy Conservation Program covers:

- ▶ Gas Fired Warm Air Furnaces (AFUE Rating > 80%)
- ▶ Gas Fired Steam Boilers (AFUE Rating > 82%)
- ▶ Gas Conversion Burners (must have electronic ignition and flame retention or premix design)



- ▶ Gas-Fired Hot Water Boilers (AFUE Rating > 82%)
- ▶ Indirect Water Heater (attached to a gas-fired boiler)
- ▶ Instantaneous Hot Water Heaters (Gas -Fired) (must have energy factor of .82 or higher and electronic ignition)
